Cllr D Mason stated that he had received contact from Lyndon Griffiths. Ceredigion County Council and there was intention to arrange a site meeting to discuss the parking issues within the next fortnight

A10143 Application to install 225KW wind turbine at Pencwm, Penrhyncoch - The application was discussed and considered at length. Local residents had been informed by letter dated 21 May of the application, the Community Council received an application that was dated 3 June - which had caused embarrassment to members with people enquiring about the application without members knowing the details. It was resolved to write to Planning Department to complain of timings and also to inform them that there was a huge amount of concern and apprehension regarding the application. Clerk to ask for a site meeting so that full discussion and to gather information. It was

also suggested there may be a need to hold a public meeting so that local residents can be fully informed.
