Maes Seilo Penrhyncoch : Derbyniwyd llythr ac adroddiad oddiwrth Tai Ceredigion ynglun ar cais ddiweddar am fwy o ardaloedd parcio ar Ystad Maes Seilo ac hefyd Tan y Berth. Ar ol gwneud archwiliad manwl or gwahanol bosibiliadau, nid yw'n bosib darparu ardaloedd parcio ychwanegol ar hyn o bryd. A letter and detailed report was received from Tai Ceredigion in respect of the application made for additional parking spaces on the Maes Seilo and Tanyberth Estates. Both areas have been surveyed and at the present time it was established that providing additional parking spaces is not possible

Penyberth, Penrhyncoch : A response was received from Huw Davies, Planning Department, Ceredigion County Council in respect of the complaints received from local residents regarding the breach of planning conditions. Mr Davies, agreed that planning conditions are being breached and that notice has been given to the owners regarding the caravan that is present on site. Clients have until the 26 September to respond. In the meantime, Mr Davies requested that should the Community Council wish to pursue the matter, written statements and photographic evidence would assist.
