3427/14 Cofnodion Cyfarfod 17 Chwefror 2015/17 February 2015

Tai Ceredigion have agreed to try to arrange a meeting with Ceredigion County Council to discuss the parking problem on the estate.

Gwteri/Gutters : Cllr E Reynolds not present it was unknown whether the gutters along the road to Pencwm had been cleared

Information was received vis Cllr D Mason that if we purchased a grit box we would be liable for the cost of refilling it with grit on each occasion. \It was resolved therefore not to purchase a new grit box, but to ask Ceredigion County Council to move the existing box from the bottom of the hill leading to Pencwm and to ask the Council to move the existing bin to half way up the hill.

3432/14 Adroddiadau ar Bwyllgorau a Mynychwyd/Reports from Committees

Derbyniwyd adroddiad o gyfarfod Y Cyngor Sir I drafod dyfodol cartrefi yr henoed o fewn Ceredigion. Ar hyn o bryd mae sefyllfa Bodlondeb yn fregus ond fod Cartref Tregerddan yn weddol saff ar hyn o bryd. Disgwylir ymgynghoriad pellach cyn ddiwedd Mis Ebrill.

A report was received regarding the Ceredigion County Council meeting that was held recently to discuss the future of the residential homes within Ceredigion. It appears that Bodlondeb is in a very precarious position but that Cartref Tregerddan is relatively safe at present. A further consultation is expected before the end of April.

Glanceulan : Cllr R Owen reported a faulty light opposite 31 Glanceulan clerk to report to Ceredigion County Council/Adroddodd Cyng R Owen fod y golau tu allan i rif 31 Glanceulan ddim yn gweithio. Clerc i adrodd at y Cyngor Sir.
