Clerk i gylchredeg copi or llythyr llawn ir aelodau.

**Plas Gogerddan** – Dywedod Cyng D Mason ei fod wedi derbyn nifer o gwynion oddiwrth drigolion lleol yn glun a chyflwr y Plas. Mi fydd Cyng Mason yn ysgrifennu at adran ysadau y Brifysgol.

Cllr T Lewis mentioned that there are a number of properties owned by the University that are currently vacant locally, and this was not acceptable due to the fact there are numerous young people who need accommodation locally.

Cllr E Davies stated she had noticed that a cabin had been placed on the roadside near Maes Y Rhosyn. Clerk to report to Ceredigion CC.

Also, that there is a sudden drop from opposite the old post office into the river, which could prove dangerous to pedestrians walking by. Clerk to report to CC.

Following recent hedge cutting the machine has broken the black and white bollards between Tyngelli/Postbach.Penbontrhydybeddau. Clerk to approach Ceredigion CC.
