15 Materion yn Codi / Matters Arising

Maes Seilo – Nid oedd Cyng D Mason wedi cael cyfle I gyfarfod gyda Neil Hinchcliffe, Pennaeth Ystadau CCC I drafod clurior ardal gogyfer parcio.

Cllr D Mason had not had an opportunity to meet with Neil Hinchcliffe, Ceredigion CC head of estates to discuss the area's car parking.

Ardwyn – There was no further information available.

Maes-y-rhosyn – Dim gwybodaeth pellach ynglun ar caban ar y briffordd yn llanw man pasio. Roedd angen symud y caban. Clerc I herio'r CCC

No further information available, The cabin was on the highway obstructing a passing place. It needed removing. Clerk to chase CCC

Y Parc: Dywedodd y clerc ei bod wedi gofyn i Aled Jones gynnal a chadw y darn tir ar ochr Glan Ceulan.or llwybr. Nid oedd y gwaith wedi ei wneud eto. Clerc I herio.

The clerk confirmed that she has asked Aled Jones to maintain the grass area on the Glan Ceulan side of the footpath. The work had not been done yet. Clerk to chase.

Golau Stryd/Street lighting – Cadarnhaodd Cyng D Mason fod arolwg yn cael ei wneud yn y flwyddyn ariannol Newydd. Mi fydd golau Newydd yn cael ei sefydlu rhwng sgwar Penrhyncoch ar garej. Yn fuan. Doedd dim dyddiad wedi ei gyhoeddi eto

Cllr D Mason stated that a review of street lights will be undertaken in the new financial year. A new light is to be erected between Penrhyncoch square and the garage soon. No specific date had been arranged at present

Caban Bws/Bus Shelter – Dywedodd y clerc ei wedi trafod y mater gyda'r Cyngor Sir, a fydd yn trefnu cael to Newydd ar y caban bws yn y dyfodol agos.

The clerk said that she had discussed the matter with the county council who will be arranging a new roof on the bus shelter in the near future.

The Clerk has requested that CCC brush the road through Penrhyncoch.

No barrier had been installed. Cllr D Mason had also contacted the county Council. Clerk to chase CCC again

Banc Y Darren – Nid oedd yn wybyddus a oedd y gwaith cynnal a chadw i'r ffordd ger bwlch y Dderwen wedi ei gyflawni.

It was not known whether the maintenance work to the road near Bwlch Y Dderwen had been carried out..
